Annual Meeting and Regional Conferences The Academy's Annual Meeting is perennially the world's largest gathering of neurologists. In 2015, attendance at the Annual Meeting in Washington, DC, was 13,583, the most attended Annual Meeting to date. More than 2,600 research abstracts were presented and leading experts on a vast array of neurologic diseases discussed the latest research results and clinical applications. The meeting featured over 170 continuing medical education courses that were strongly attended by neurologists looking to update their knowledge and skills and prepare for recertification. Programs also were dedicated to helping practicing neurologists and business managers run more efficient and effective offices and clinics. The Academy also communicated its advocacy priorities and success and urged greater member participation. The 2015 regional Fall Conference attracted 619 attendees. The Fall Conference provides updates on neurology diseases and practice management improvements for neurologists and practice managers, particularly those who need to fulfill annual continuing medical education requirements by year end. In 2015, we offered the second annual Sports Concussion Conference. The conference focused on combining the education and scientific breakthroughs impacting the diagnosis and treatment of concussion. Clinical Practice and Practice Guidelines In 2015, the AANI published four guidelines in Neurology(R). Two of these publications included evidence for diagnosis, management, and treatment of patients with congenital muscular dystrophy and facioscapulohumeral muscular dystrophy. Both of these projects were supported, in part, by a federal grant from the Centers for Disease Control and Prevention. AANI published a guideline on treatment of adults with a first unprovoked seizure. The guideline was highlighted at the AAN Annual Meeting with a press conference with the lead author, Dr. Allan Krumholz, and with Dr. Jacqueline French, co-author and Guideline Development, Dissemination, and Implementation Subcommittee member. The final guideline reviewed the evidence for idiopathic normal pressure hydrocephalus: response to shunting and predictors of response. The AAN also developed a clinician summary, patient summary, slide set, and a video educating viewers on the evidence regarding the procedure. Quality Measures and Clinical Registry In 2015, the AAN updated its measure sets for dementia, Parkinson's disease, and stroke and developed new clinical quality measures for inpatient and emergent neurology. The AAN also provided tools and resources for neurologists to use for quality improvement and to assure safe patient care. In 2015, the AAN

Continuing Medical Education Programs The AANI offers a number of resources to help neurologists with professional development and maintenance of certification (MOC), as required by the American Board of Psychiatry and Neurology. The AAN provides continuing medical education-a necessary component of MOC and licensure-in print (Neurology(R), Continuum(R)) and in digital formats (Neurology(R) Podcast, Continuum(R) Audio, NeuroSAE, Practice Management Webinars), as well as through on-site programs at the Annual Meeting and regional conferences. The number of AAN members subscribing to or participating in these programs has increased, especially now that NeuroPI, NeuroSAE, and NeuroLearn are offered for free with membership.

In line with Minnesota Law, the final Form 990 was brought to the Board for discussion and approval (as required by state law) at a regularly scheduled meeting. The Form is then filed after this process.


